# ADMISSION OF FOREIGN DOCTORAL AND POST-DOCTORAL STUDENTS

The Coordinating Committee of the Graduate Program in Chemistry at the Federal University of Rio Grande do Sul, in a meeting held on July 26, 2017, in the use of its attributions,

## **DETERMINES**

- **Art. 1** That for admission as a foreign postdoctoral student to the Graduate Program in Chemistry, the candidate must:
- (i) Respect the Resolution 26/2011 CEPE/UFRGS which deals with the Norms for the participation of Post-Doctoral students in Scientific and Technological Research and Teaching activities at the Federal University of Rio Grande do Sul.

**Sole paragraph**. The postdoctoral supervisor must be a permanent professor at the PPGQ.

- **Art. 2** That, in order to prove a source of funds to support the Post-Doctorate, in addition to Resolution 26/2011 CEPE/UFRGS, the Program will accept the candidate's proof of a scholarship arising from bilateral collaboration agreements between their country origin and Brazil or scholarships arising from agreements with companies and industries.
- **Art. 3** That, for admission as a foreign doctoral student at the Program, the candidate must have a Master's degree in Chemistry or a related area, or a degree equivalent to a Master's degree.

**Sole paragraph**. The master's degree must have been completed before starting the doctorate.

- **Art. 4** That, for admission as a foreign doctoral student at the Program, the candidate must have been formally accepted by a professor of this Graduate Program, able to be supervised according to the Graduate Program criteria.
- Art. 5 That, for admission as a foreign doctoral student at the Program, the candidate must have been approved as a scholarship holder of a national or international development institution or have been awarded a scholarship arising from bilateral collaboration agreements

between his country of origin and Brazil or have been awarded a scholarship from agreements with companies and industries.

- **Art. 6** Each case will be analyzed by the Coordinating Committee of this Graduate Program in Chemistry, and candidates must have an academic profile similar to that of Brazilian candidates accepted in the Program.
- **Art. 7** Admission will be made at any time, and applicants must fill in a specific form to be made available by the Program Committee.
- **Art. 8** Situations other than those specified in this resolution will be analyzed by the Graduate Committee.

Art. 9 - This resolution revokes Resolution 06/2008.
